JOB TITLE	REPORTS TO:	DESCRIPTION
**President and Chief Executive Officer	Board of Directors	Responsible for directing, managing and leading VELCO in all regulated activities and operations.
**Vice President, Transmission Services	President and CEO	Responsible for directing, managing and leading field activities of engineering, system operations, asset maintenance, telecommunications, environmental management, business development and project controls and scheduling.
**Vice President, Secretary and General Counsel	President and CEO	Responsible for directing, managing and leading corporate secretary department and corporate legal department. Oversees company security officer and OASIS administrator.
Accounting Manager and Treasurer	President and Chief Executive Officer	Responsible for leading accounting and power accounting. These functions include accounting, budgeting, forecasting, capital structure management, regulatory financial reporting, and settlements.

System Planning Engineers	Team Lead, Planning	Responsible for system planning activities.
Team Lead, System Protection	Director of Engineering, Planning, Protection and Telecommunications	Responsible for all transmission system protection engineering, relay and substation design.
System Protection Technicians	Team Lead, System Protection	Designs system protection and relay systems and maintains protective relay data for the transmission system.
Operations Manager	Vice President, Transmission Services	Leads and directs staff and resources for the Company's power system operation functions.
Outage Coordinators	Operations Manager	Responsible for coordinating planned outages of the Company's transmission facilities and other utilities. Assists in the minute-to-minute operation of the transmission system.

		the communication links from the ISO-NE Control Center and the control centers of interconnected out-of-state utilities to and among the Vermont distribution utilities for system operation purposes. Manages the on line operation of the transmission system taking corrective action in form of switching capacitors, adjusting load tap changers, dispatching local generation as necessary to maintain voltage and power flow levels. Operates and monitors the EMS for the purpose of performing real-time security analysis as well as studying the security impact of scheduled outages on transmission system.
Operations Training Coordinator	Operations Manager	Responsible for developing, designing, implementing and evaluating the Company's Operations personnel training.
Manager, Transmission Line Construction	Vice President, Transmission Services	Responsible for directing and coordinating construction and maintenance activities required to insure the integrity and reliability of the Company's transmission system.
Team Lead, Asset Maintenance	Vice President, Transmission Services	Responsible for all equipment and inventory associated with the exclusive support of the transmission system.
Manager of Power Accounting <sup>1</sup> and Internal Audit	Accounting Manager and Treasurer	Responsible for leading power accountants, market analysts, metering and customer support analyst. Oversees OASIS administrator.
Team Lead, Metering and Settlement	Manager of Power Accounting and Internal Audit	Oversees and directs the execution of the daily metering, market settlements and monthly power

Also includes the accurate creation and distribution of all information shares to other New England assigned meter readers.
