Highgate Purchase

Vermont Transco, LLC (VTransco) acquired an 87.03% ownership interest in the Highgate Transmission Facilities (HTF) on May 31, 2017. The transaction, authorized by FERC and the Vermont Public Service Board (VTPSB), provides for the transfer at net book value of the undivided interests of the Highgate Joint Owners (HJOs) except for Burlington Electric Department's (BED) share and a portion of Vermont Public Power Supply Authority's (VPPSA) share purchased by Stowe. (1)

For the Regional Network Service (RNS) rate effective June 1, 2017, the associated HTF investment is concurrently included in VTransco's and the HJOs' Forecasted Transmission Plant Additions (FTPA) as positive and negative values, respectively. (2) Because of the HJOs' negative 2017 forecast, only their residual Annual True-Up (ATU) to 2016 actuals remains in the June 1, 2017 RNS rate. The HJOs however continued to incur HTF-related costs from January 1 through May 31, 2017.

Although RNS recovery on a forecasted basis began on June 1, 2017, VTransco will not incur a full calendar year of HTF ownership costs until 2018. Open Access Transmission (OATT) Attachment F provides for the recovery of costs incurred by its Related Persons as the basis for establishing its Annual Transmission Revenue Requirement (ATRR) until such PTO has a full calendar year of cost data under its ownership. VTransco will rely on and disclose in the notes to its 2017 FF I, the HJOs' 2017 costs incurred through May 31 for purposes of establishing its Annual Transmission Revenue Requirement (ATRR) for the June 1, 2018 RNS rate. (3)

VTransco accrued and reimbursed the HJOs for their 2017 ownership costs at closing. (4) Such costs will be amortized monthly as an offset to RNS revenues over the 12-month period beginning July 2017. The amortization period matches VTransco's recognition of RNS revenue associated with the 2017 forecasted HTF revenue requirement. (5)

Utopus
